The Annual Town Meeting of Hinckley Township was called to order by Clerk Angela Charchenko at 8:15pm, with 17 people in attendance.

Pledge to the flag.

Call for nomination of moderator, Betty Reiter nominated Linda Dvorak. Motion by George Gimpl and seconded by Justin Hanson for Linda as moderator. All agreed.

- 2023 annual meeting minutes were read by the clerk and a motion by George Gimpl and seconded by Grayling Wachsmuth to accept the minutes. All agreed.
- The supervisor's report was read by Grayling and a motion by Justin Hanson and seconded by Grayling Wachsmuth to accept the minutes. All agreed.
- The treasurer's report was read by Betty Reiter and was accepted with a motion by Barb Woody, seconded by Bryan Dvorak. All agreed.
- Discussion over fire tax levy. In a motion by Bryan Dvorak and seconded by Barb Woody to leave the fire tax levy at \$30,000. All agreed.
- Discussion of road and bridge levy. A motion by Barb Woody and seconded by Betty Reiter to keep the levy at \$115,000. All agreed.
- Discussion of general revenue levy. It was decided to raise the levy to \$30,000 with a motion by George Gimpl, seconded by Bryan Dvorak. All agreed.

Old Business:

- Discussion of 3 road inspections and snow pushing – non issue with no snow this year.

New Business:

- Discussion of cable burying and rocks/dirt in the ditches. Motion by Bryan Dvorak, seconded by Julie Nelson for supervisors to contact contractors on the issue. All agreed.
- Discussion of zoning information and how to get the information to new buyers of property through real estate agents. Good idea, just no way to implement. Zoning ordinances posted on township website and available at the library.
- Hunter road – current status. Owner has been asked to remove gate by certified letter. Awaiting attorney information.
- 2024 road work – regravelling and replacing a couple culverts.
- Preliminary election results:
  - o John Moffatt 35 votes for supervisor
  - o Cheri Carlson 37 votes for supervisor *Clerk (cc)*
  - o No Write-Ins

Pawnmaster – same as previous year. Problems with animals between neighbors need to be settled amongst themselves, not involving the township board with a motion by George Gimpl, seconded by Joe Sweep. All agreed.

Next township annual meeting will be held on Tuesday, March 11<sup>th</sup>, 2025 at 8:15pm with the election running from 3 -8pm is accepted with a motion by Barb Woody, seconded by Betty Reiter. All agreed.

The meeting was adjourned at 8:54pm with a motion by Justin Hanson and seconded by Grayling Wachsmuth. All agreed.
